Aida Padilla-Cruz has been volunteering with Veterans associations on Kauai since 2009. Her dedication is to be commended. She has been an Honorary Trustee for the Kauai Veterans Museum on the fundraising committee since 2009. During her 13 years with this committee, she has helped raised over \$100,000 to help with renovations and sprucing up of the Kauai Veterans Center and the Kauai Veterans Museum. This was accomplished by fundraising events such as golf tournaments, line dancing, movie nights and a food truck challenge.

Pre-Covid era, Aida was also instrumental in very successful Veterans Christmas Luncheons by helping arrange musical entertainment, food, beverage and door prize donations for nearly 300 attendees.

Since 2012 Aida has been on the Kauai Veterans Council as an Events Volunteer and on the Kauai Vet Center Management Committee as Resource Manager. During this time Aida has helped with grant applications, overseeing individuals who are court mandated to perform community service at the Vet Center and brought in student Veterans enrolled in Kauai Community College to attend and be part of the Kauai Veterans Council meetings. During this time, she has also been a volunteer organizer for the Veterans Day Parade, soliciting donations to defray costs, contacting rental companies to provide free transportation for honorees and overseeing registrations of parade entries.

Aida is also very dedicated to the Catholic Church. She was the President of the Kauai Board for Catholic Charity from 2016 to 2018, engaging in youth ministries at Holy Cross, St. Theresa, St. Raphael and Sacred Heart Catholic churches. She taught catechism to pre-school children, using arts and crafts to teach Bible stories, Confirmation to intermediate age groups and created a mentoring class for students who had been confirmed. Aida also bridged the gap between the youth and kupuna by bringing them together to practice manners and table etiquette, as well as planning and chaperoning social events for them.

In addition to her involvement with Veterans and the Catholic Church, Aida has also volunteered with Relay for Life since 2007. Being a cancer survivor herself and having lost her husband to this terrible disease, this is a personal mission for her. She not only solicits monetary donations but has also manned the information table.

The impact Coleen Kasperek has had on countless Kauai residents through her work with the AARP Tax-Aide Program is immeasurable. Since 2007 she has been the District Coordinator and an Instructor for this program. She is responsible for overseeing and coordinating the annual schedule for preparing returns which includes, securing locations, scheduling volunteers, establishing times of operation and finalizing site operations procedures. She also must be up to date on any tax law changes, AARP Tax-Aide policies and procedures, IRS Certification requirements and deadline requirements for training and certification. On the technology side, she must ensure the routers are secure and the computers and printers are all working and meet AARP and IRS standards and requirements. During tax season she oversees all the workings of tax preparation provided by the volunteers and at the end of each session she is responsible to make sure all equipment ,supplies, activity logs and other required documentation is accounted for. The work is seemingly endless.

Since 2014, Coleen has been a Disaster Action Team Member for the American Red Cross. These members are among the first people at a disaster site to provide comfort and assistance to those in need. She has opened and managed temporary shelters and assisted people in securing shelter, food and other necessities when they are displaced by a disaster.

Coleen is also an active member of Holy Cross Church and has served on the Parish Pastoral Council for many years. The Council works closely with the parish priest, plans, organizes, coordinates, implements, monitors, and evaluates the pastoral programs and activities of the parish.

The same dedication Coleen has in her volunteer work was also evident in her professional career as an industrial engineer. Three companies she collaborated with won prestigious awards as a direct result of her work. Two in Arizona won the Arizona Quality Award and one in California won the California Quality Award.

Coleen and her husband, Brian, moved to Kauai in 2003 and have been contributing community members ever since.
